I am the authorizing official responsible for making the determination required by Section 1004.5(b) of Department of Energy (DOE) regulations found at 10 CFR Part 1004, implementing the FOIA, 5 U.S.C. 552. This letter is in final response to your subject FOIA request.

Your request has been assigned control number #CH-2010-01277-F.

You stated the following in your FOIA request:

“I am requesting copies of the following information:

The Organizational Chart for The Office of the Chief Information Officer / the Organizational Chart for the Information Technology Division of the Brookhaven National Laboratory - something that includes the names and titles/departments of the people who report to the Chief Information / Chief Technology Officer of the Brookhaven National Laboratory. I also ask that this chart contains the next level of management, those people who report to people that report to the Chief Technology Officer / Chief Information Officer. Also, contact information on the people listed in the above organizational chart to include: Business Address, Direct Business Telephone Number, and Business Email Address would be greatly appreciated.”

In response to your request, be advised that we asked Brookhaven Science Associates LLC (BSA), operator of Brookhaven National Laboratory (BNL) to conduct a search for responsive records, and BSA located the attached responsive records. In addition to the
