Hello Lynne,

The following is our response to your FOIA request:

I am the authorizing official responsible for making the determination required by Section 1004.5(b) of Department of Energy (DOE) regulations found at 10 CFR Part 1004, implementing the FOIA, 5 U.S.C. 552. This letter is in final response to your subject FOIA request.

In your request you were seeking "a copy of the basic awarded contract, including the statement of work" for "Contract #DEAC02-06CH11377 awarded to CNI Information Technology."

Be advised that it has come to our attention that the contract you are requesting, as well as a subsequent modification to that contract, had been requested under FOIA by another requester some time ago; and at that time, we had secured the necessary submitter's views from the awardee as is required under FOIA. Therefore, we have determined that no additional submitter's views are necessary for this request. Pursuant to our practice to post any document requested more than once to our FOIA website, we have now posted the contract you requested (and the subsequent modification to the contract previously requested under FOIA) on our FOIA website at the following link:
